PROMOTE

RBC Sponsorship

RBC announced its three year partnership with Sport North for a total investment of \$165,000 through donations and sponsorship.

Strategic Plan

Sport North periodically reviews its operating environment, including the strategic priorities of the Sport and Recreation Council (SRC); considers the needs of its member organizations and athletes; and responds to its evolving circumstances. The 2009 to 2014 strategic plan was developed and approved by the Board of Directors.

Awards

The Sport North awards play a valuable role in supporting athletic success and recognizing the NWT's growing talent. This year's award recipients are profiled throughout this document. Sport North will be establishing a new award, to be presented in 2010, in memory of Delma Kisoun, who was a Board Member from 2001 to 2005 and died in a boating accident in July 2008.

Funding Process

Sport North provides funding to its active members through an on-line application and accountability process. This year, the sports were designated into a winter or summer category in an effort to streamline the review process and allocate funding prior to their active season.

Role Models

Celebrity athletes were in Yellowknife (September 2008) for the RBC Champions for Children Dinner: Beckie Scott (two-time cross-country ski Olympic medalist), Kevin Martin (Olympic curling silver medalist and current World Champion and Brier Champion), Mike Bossy (NHL Hall of Fame great), Megan Metcalfe (2008 Beijing Olympics – athletics) and David Bissett (2006 Turin Olympics and silver medalist at World Championships – bobsleigh). Some of the athletes attended local schools to speak about their Olympic experience and met with their designated sport group for athlete and coach development sessions.

Scholarships

Sport North provides financial assistance to NWT students at a recognized post-secondary educational institution through our scholarship program. Academic excellence, dedication to sport and future education plans are taken into consideration in determining scholarship recipients. Ten scholarships were distributed this year.

Sponsors

Sport North has developed partnerships with companies that share in our goal to promote and develop sport across the Northwest Territories. Our programs have benefited greatly from their continued support over the years.

PARTICIPATE

Sogo Active

Coca-Cola Canada announced a new physical activity program called Sogo Active, a national program to inspire youth to get active using the excitement of the Olympic flame. Teens 13 to 19 create a unique profile for themselves on-line where they can network and find a range of traditional and non-traditional activities that fit their needs, interests and lifestyles. Youth that register with sogoactive.com and commit to an active lifestyle are eligible to be selected as a torchbearer in the 2010 Olympic Torch Relay. Sogo Active is administered in the Northwest Territories by Sport North.

Community Sport Opportunity

This program creates sport development opportunities and mentorship that will benefit smaller communities by increasing the number of participants, coaches and sport leaders in the community. Funding for this program is available through the Pan-territorial Sport Strategy, a multi-year funding agreement between the Government of Canada, Government of the Northwest Territories and Sport North. Twelve sports received funding and delivered sport development activities.

KidSport™

KidSport™ is a charitable program that provides support to children in order to remove financial barriers that prevent them from playing organized sport. A total of 139 kids benefited from financial assistance in 2008 and \$31,700 was distributed. Sport North administers the KidSport™ program for the Northwest Territories.

RBC Champions for Children Dinner


The RBC Champions for Children Dinner identified KidSport™ as their charity of choice for 2008 and raised \$70,000. This is the first year that RBC has been a major sponsor and we look forward to continued success over the next two years. RBC contributes to this event both financially and through the engagement of their employees.

Membership

Sport North has 28 active members – Territorial Sport Organizations – and 18,130 members in 32 communities. We would like to welcome our newest member – NWT Judo.

Rising Star

The Rising Star Program funds athletes (14 years and under) to attend sport specific camps outside the NWT. This program was developed to encourage younger athletes to stay involved in sport and be exposed to southern training opportunities, facilities and coaches. Nineteen athletes received funding in 2008.

TSO Support

Territorial Sport Organizations (TSOs) are non-profit organizations that provide sport development programs to their members across the Northwest Territories. In an effort to assist these organizations, which are administered entirely by volunteers, funding was allocated for administrative support. The TSO Support Program assists with retaining the services of qualified sport leaders to offer sport specific training, technical assistance and coaching services for the public and their membership. This program is a joint initiative between the Government of Canada, the Government of the Northwest Territories and Sport North. In 2008, five sports/groups were approved for funding.

Multi-sport Games Review

The Government of the Northwest Territories conducted a review of all multi-sport games to determine a basis for assessing the appropriate level of investment and quantify what results can be achieved as a result of the investment level. This review focused on the Arctic Winter Games, Canada Games, Western Canada Games and the North American Indigenous Games. Sport North received the final report along with a list of recommendations in April 2009, and the Sport and Recreation Council has confirmed that Sport North will administer the 2010 Arctic Winter Games for Team NWT.

Alternate Dispute Resolution


Sport North recognizes the right of its members to appeal its decisions and has established an Alternate Dispute Resolution Policy as a process for resolving disputes that may arise from time to time. In addition to this, four individuals were trained in mediation, a process of dispute resolution where a mediator or trained negotiator assists parties to a dispute in negotiating a settlement.

High Performance Athlete Grant

The High Performance Athlete Grant is funded and administered, in a joint effort, by Sport North and the Government of the Northwest Territories. This funding program has been a key factor in the success of our northern athletes when they represent the Northwest Territories on the national and international scene. This is the fourth year that this funding has been available.


