- 5. Fares are subject to applicable taxes, surcharges and fees, and may change without notice.
- Tickets are fully refundable to original form of payment if reservations are cancelled at least two (2) hours
 prior to departure. Failure to cancel flights at least two (2) hours prior to departure will result in coupons
 being forfeited and the unused coupons will have no value.
- Changes to dates of travel are permitted without penalty. Failure to change flights prior to departure will
 result in coupons being forfeited and the unused coupons will have no value.
- 8. Name changes are permitted on fully unused tickets without penalty.
- When making a name or date change, and upon rebooking a travel credit, if segment is of higher value, change fee as well as any fare difference will be applied.
- Should a fare type other than this contract fare be purchased, all rules associated with purchased fare type will apply.
- Tickets must be paid in full at least fifteen (15) days prior to departure. If booking is made within fifteen (15)
 days of departure, tickets must be paid in full at time of booking. Tickets cannot be charged to an account.
- 12. If a group reservation is not ticketed at time of booking, a \$50.00CAD non-refundable deposit will apply per person. This deposit will be subtracted from the final balance owing. For any seats that are cancelled after the original booking, the deposit will be considered forfeit.
- 13. Passengers are entitled to two (2) complimentary pieces of baggage to a maximum of 50lbs each.
- 14. Sport North agree to meet a performance goal of \$75,000 CAD in flown revenue during the term of this agreement. Should this performance goal not be met, First Air may be unable to extend this agreement
- 15. Cancellation of this contract is subject to 30 days written notice by either party.
- 16. This agreement must be signed and accepted within 30 days of issuance by both parties in order to be valid.
- 17. First Air will have first right of refusal over any other major air carrier to sponsor any Sport North event.
- 18. Sport North will designate First Air the Official Airline for their clinics and tournaments by displaying First Air banners, and will have a direct link to the First Air website on the Sport North website.

19. Both parties agree to review this agreement annually and extend at mutual consent of both parties in advance of expiry date (1).
